# The Public Health Significance of the Modern Holographic View of the Consciousness

**Individual and Collective Consciousness and their Global Significance.** Consciousness has been the central theme from the beginnings of philosophy. The first attempts to explain its nature appeared in psychology in the 19th century through the personality theory, and then parapsychology, which contributed to the modern holistic drift of *Integrative Medicine*. This problem is further explored by *Quantum Mechanics* and *Artificial Intelligence*. Within *Quantum-Holographic/Quantum-Gravitational Framework of Consciousness*, *Transpersonal Phenomena* are of psychosomatic nature, with the central role of *Acupuncture System* which can be in a blocked state. This leads to the personal disintegration as is in some forms of addictions. The unraveling of the *Transpersonal Energy Blockade* (Ayurvedic/Qigong/Reiki) initiates the process of permanent healing even at the level of *Collective Consciousness*.
